Bhalu Mondhe has been an avid nature lover for over 50 years now. He is an acclaimed wildlife photographer. Besides being a professional lensman, he is also a painter and a sculptor of repute. His love for photography took him to every nook and

corner of India. He first visited the Kanha National Park to photograph tigers and enjoy the verdant jungle, much before it was formally declared a tiger reserve under the Project Tiger 1972.

His long stints in Europe and America made him a confirmed environmentalist. So conserving nature became his second nature! His untiring efforts helped protect and conserve a severely threatened bird habitat and wetland called

Sirpur Lake, Indore, along with its flora and fauna. Twenty five years down the line, Bhalu Mondhe is a well known name in the fields of environment, wetland protection and bird watching. He was awarded the prestigious civilian honour Padma Shri in 2016 by the President of India.

ABHILASH KHANDEKAR Hon Vice-President and Co-Founder



Even after being elected to the prestigious position of Madhya Pradesh's richest sports body-MP Cricket Association (MPCA) as President in October 2019, his interest and

Looking to his passion and ability to deliver, the MP Government again nominated him on the MP Wildlife Board in (2020-23) & then inducted him into the newly formed MP Wetland Authority for a period of three years (2020-2023). The Wetland Authority has been constituted under the chairmanship of the Environment Minister of the State and as per the

legal directives of the (MOEFCC), New Delhi.



SECRETARY'S REPORT

The Nature Volunteers (TNV) continued its journey of conservation, awareness, and community engagement throughout 2024–25 with impactful programmes and significant collaborations. The year was marked by a strong presence in both Indore and Bhopal, with activities centering on birding, biodiversity, book publishing, and environmental education. The major highlight was the launch of the much-anticipated Coffee Table Book 'Birds of Bhopal', released at Hotel Jehan Numa Palace by the Deputy CM Shri Rajendra Shukla and Water Resources Minister Shri Tulsiram Silawat. The book celebrates the avian diversity of capital city Bhopal and reflects TNV's vision of combining science with aesthetics and ecology for public awareness. Literary discussions and presentation of the book to dignitaries like Hon'ble CM Dr. Mohan Yadav and other senior functionaries of government and environmentalists further amplified its reach.

TNV also hosted thematic sessions on snakes, butterflies, sparrows, urban tigers and wetlands by engaging students, citizens, and nature lovers. Events such as World Wetland Day, World Tiger Day, Vulture Awareness Day, and World Sparrow Day fostered deeper public understanding of lesser-known species as well as the flagship species. The launch of a bee trail in collaboration with UTMT Mumbai in Bhopal marked an exciting new focus on pollinator conservation and added to our field activities. We thank Ms Sujana Krishnamoorthy, ED of UTMT, Mumbai. We have been regularly partnering with UTMT for bee conservation. Already, three functions have been held in Indore and Bhopal together, though the Bee Trail is first such trail set up in entire Central India. It has been set up at the Barkatullah University's sprawling campus. We are thankful to the V-C (Kulpati) Dr Suresh Jain and Prof Vipin Vyas.

It is heartening to note that last year, for the first time, we ran a month-long environment awareness course for Ahmedabad's Nirma University students, and others. This internship programme was a great success with domain experts from select sectors such as water, air pollution, climate change, wildlife, biodiversity and ornithology, giving lectures and conducting field visits in different parts of the Indore city. TNV Society hopes to make this a regular feature in an effort to build up an army of young environment volunteers for the future.

Our ongoing field campaigns and social media campaigns like 'Don't Feed Pigeons' addressed the urban ecological and public health concerns, while TNV's participation in tree-cutting protests, plantations, and discussions underlined our commitment to the cause of urban biodiversity conservation. For stopping the pigeon-feeding fads, we have connected with many NGOs/CSOs, friends, social organisations in Pune, Mumbai, New Delhi, Jabalpur, Vidisha, Ujjain, Bhopal, Neemuch and various other cities to help generate awareness on this front. If we don't realise the dangers involved now, it could soon become a medical emergency in India. We also profusely thank young pulmonologist Dr Prakhar Agarwal of the AIIMS, Bhopal for releasing a science-based finding through a video thus cautioning people against constantly feeding the Indian rock pigeons at their terraces, public squares and temple premises. Unfortunately, urban educated people are oblivious of the grave ramifications of their acts.

We take this opportunity to express our gratefulness to all those who supported us throughout the year. Special thanks to Mr. Peter Smetacek, the well-known butterfly expert from Uttarakhand who delivered the IXth Annual Environment Lecture (AEL) at a well-attended gathering. Thanks are also due to the Indore Municipal Corporation (IMC) Commissioner Shri Shivam Verma, IAS for releasing our Hindi butterfly booklet at Sirpur Lake, and Shri Abhilash Mishra, IAS, Additional Commissioner, IMC for his constant support in conservation of Sirpur Lake and its ecology. Dr. Satish Pande, Shri Pramod Deshpande (Ela Foundation, Pune) have cooperated well with TNV for the 'Birds of Bhopal' Coffee Table Book's beautiful production and editing. We owe a lot to Shri Ashok Barnwal, IAS (ACS-Forest), Shri Aseem Shrivastava, IFS (HoFF Govt of MP) and Shri S S Shukla, IAS (PS Tourism), besides senior managers of IPCA Laboratories Pvt Ltd, Ratlam for their encouragement and collaboration in the publication and release of the first-of-its-kind documentation on Bhopal's 312 species of birds. TNV will not forget the unflinching support by Shri Arun Bhatt, former Chairman of State Environment Impact Assessment Authority (SEIAA), Bhopal, who made the production of the classy book possible. The Coffee Table Book and the Field Guides were printed in a record time and with top quality by Shri Nimesh Goenka of the Goenka Offset Printers Pvt Ltd Indore. We are also thankful to the MP Biodiversity Board, Bhopal and its member-secretaries Shri Atul Shrivastava, IFS and Shri Sudeep Singh, IFS for their constant support in our endeavors. An number of District Forest Officers (DFOs) promoted our snakes, butterflies and bee booklets among their staff. Thank you friends, thank you from the bottom of our hearts.

Thanks are due to CABT & its Trustees Prof SK Bandi (chairman) and Secretary shri Laxmikant Patel for their sincere cooperation. With growing youth participation and strong partnerships, TNV continues to build on its mission of 'Conservation through Education'—creating ripples of awareness, action, and hope for a greener tomorrow. Indeed, we look forward to more on-field projects to bring about necessary changes and help arrest the rapidly deteriorating trend of biodiversity degradation.

Key Events & Activities 2024-25:

12 May 2024 - Bird Watching Tour for Nirma University Interns

TNV conducted a bird-watching session at the Daly College, Indore, for a group of internship students from Nirma University, Ahmedabad. TNV Vice President Shri Sajid Lodi led the tour, educating the interns about bird species, habitats, and identification techniques.

30 June 2024 - Protest to Save Trees

TNV members participated in a peaceful protest against the felling of old trees at Malhar Ashram School, located in the heart of Indore. Several concerned citizens joined hands to raise awareness about urban deforestation.

16 July 2024 - Snake Awareness Session

A session on snakes was conducted at TNV Office, Race Course Road, Indore, by young volunteer Yogesh Mimrot, who educated attendees about local snake species, their role in the ecosystem, and busting common myths.

17 July 2024 - Launch of 'Birds of Bhopal' Coffee Table Book

The visually captivating book Birds of Bhopal was launched at Jehan Numa Palace, Bhopal, by Deputy CM Shri Rajendra Shukla and Water Resources Minister Shri Tulsiram Silawat. The event was attended by senior officials, birders, and environmentalists in a big number. It has covered 312 species found around the State capital.

29 July 2024 - International Tiger Day Event

A talk and film screening by renowned wildlife expert Shri D.P. Shrivastava, Bhopal was organized in Indore. He shared insights into the life of urban tigers of Bhopal, drawing interest from students and nature enthusiasts. TNV also released an art piece- a brass tiger paw for wildlife experts and tiger lovers.

10 August 2024 - 'Ek Ped Maa Ke Naam' Initiative

TNV participated in the tree plantation campaign organized by Akashwani Radio, reinforcing the message of green cover preservation and community action.

16 August 2024 - Book Presented to Honourable CM

TNV's Co-founder Shri Abhilash Khandekar presented a copy of Birds of Bhopal to Honourable Chief Minister Dr Mohan Yadav in Bhopal.

17 August 2024 - Distribution of Book to Members

TNV President Padma Shri Bhalu Mondhe distributed copies of the Birds of Bhopal book to fellow TNV members and well-wishers at the TNV office, Indore.

7 September 2024 – Vulture Awareness Talk

To mark International Vulture Awareness Day, a talk by Shri Dilsher Khan, Satna, was organized at the TNV office. He shared knowledge about vulture species, their importance, and conservation status.

7 October 2024 - Butterfly Booklet Release

A Hindi booklet on butterflies was released by Shri Shivam Verma, IAS, Commissioner, Indore Municipal Corporation. The event was attended by other senior officials and TNV members.

November 2024 - Campaign: 'Don't Feed Pigeons'

TNV launched a digital awareness campaign on the risks of feeding pigeons in urban India. Rapid increase in Indian rock pigeon populations and the health hazards due to their droppings were highlighted to sensitize the educated urban individuals.

24 January 2025 - AEL-IX: Annual Environment Lecture

The 9th edition of AEL (Annual Environment Lecture) was hosted by TNV. Butterfly expert Mr Peter Smetacek from Uttarakhand was the keynote speaker. The event was moderated by Siddharth Mahajan and presided over by Shri Abhilash Mishra, IAS, Additional Commissioner, IMC.

2 February 2025 - World Wetland Day at Sirpur

World Wetland Day was celebrated at Sirpur Lake (Ramsar Site), Indore, with Mayor Pushyamitra Bhargava as the Chief Guest. TNV President Padma Shri Bhalu Mondhe, Vice President Shri Sajid Lodi, Shri Sandeep Khanwalkar, Shri Ashok Golane, and other TNV members participated.

3 March 2025 - Bee Trail Launch at Bhopal University

A bee trail was inaugurated at Barkatullah University, Bhopal, in collaboration with Under The Mango Tree Society (UTMT), Mumbai. The trail was inaugurated by Kulpati Dr Jain and aimed to promote pollinator conservation. This is the first bee trail in Central Indian states.

20 March 2025 - World Sparrow Day Celebrations

TNV celebrated World Sparrow Day in Indore and Bhopal. TNV office bearers presented sparrow nest boxes to Divisional Commissioner Shri Deepak Singh and Mayor Dr Bhargava, initiating a new awareness drive.

20 March 2025 - Bhopal Chapter event at EPCO, Bhopal



ABOUT TNV SOCIETY

The Nature Volunteers (TNV) Society is a leading environment conservation movement that began over three decades ago from Indore. TNV is now a well-known Civil Society Organisation (CSO) of the country, especially in Central India.

TNV celebrated its silver jubilee in 2016-17 and has since rededicated itself to the cause of protecting Mother Nature. We are a registered organisation with the Government of MP and are also entitled for CSR grants from private companies. We do NOT accept foreign donations from any institutions nor any regular grants-in-aid from any government. TNV is a membership-based organisation.

Since its foundation in 1992, TNV has consistently endeavoured to expand its net far and wide. Initially we were confined to a single wetland conservation project at Sirpur, an Indore Municipal Corporation (IMC) asset. Over the decades, we have conducted campaigns to save the tiger (2006), wetland conservation (1992 onwards till today), organising bird watching camps, hosting Annual Environment Lectures (AEL), conducting webinars, intervening in urban issues from time to time and organising certificate courses in ornithology. We have also been raising environmental issues at national and international fora by deputing our delegates to participate in important conferences at Jaipur (World Lake Conference conducted by ILEC in 2007), Bhopal (Jalsatyagrah National Conference on Water in 2010), Saifai (First International Conference On The Conservation of Sarus and Wetlands in 2016), New Delhi (Conference on Elephants by WTI in 2017), Pune (World Owl Conference 2019), Gandhinagar (COP-2020), Indore (Town Planners Conference), in 2023 and at other places.

TNV shot into fame, if we may say so, after almost complete restoration of the Sirpur Lake, a man-made water body which is now 140 years old. It was built by the then ruler of Indore, Maharaja Holkar, for providing drinking water to the ancient city of Indore, then a small city compared to the present metropolis. In modern days, the sprawling lake also serves as a major carbon sink as well as a top bird habitat. After much ground-level preparations and struggle by TNV, Sirpur Lake has now been declared a Ramsar Site (August 2022) by the Ramsar Convention, Geneva. The Government of India's Ministry of Environment, Forest and Climate Change (MoEFCC) and GoMP's Environmental Planning & Coordination Organisation (EPCO), Bhopal did the real work of taking the Sirpur Lake proposal, along with that of Yeshwant Sagar, another Indore wetland, to the Ramsar Convention for the global nomination they deserved, but the threats to them continue and strict vigil is needed at all times.

TNV has always believed in documentation and has thus published a number of serious books and booklets over the past years. Our members have also participated in vulture counts at Panna Tiger Reserve (PTR) and have published a pictorial book Vultures of Panna (2015) which was released by the Honourable Chief Minister Shivraj Singh Chouhan at Vallabh Bhawan, Bhopal. Other books include, Birds of Sirpur (2012), Town Planning Towards City Development: A Report to The Durbar of Indore by Sir Patrick Geddes (republished in 2016 on the centenary of the original publication), Birds of Indore (2019) and an awareness series in Hindi on environmental issues such as grey water, urban biodiversity and honeybees, snakes and butterflies. In addition to these five booklets (3000 copies of each were published at different intervals), we propose to bring more such topical booklets for the masses

with an earnest hope that awareness among laymen for vital issues surrounding our earth grows and damages done to nature gradually reduce even as human populations continue to swell, threatening biodiversity. "Educating people through various means and making them aware and empowered is the only way we can save the environment and wildlife," believes our President Padma Shri Bhalu Mondhe. With this purpose in mind TNV published a coffee table book, Birds Of Bhopal in 2024.

The Sirpur urban lake conservation success story is now well known across India but we do not wish to stop there. A recent survey conducted by TNV ornithologists showed number of avian visitors to this natural habitat is steadily growing. The new number stands at 189 species (2020) and proves that if habitats are secured scientifically, they, in turn, help protect biodiversity. After the Sirpur conservation/restoration project was almost complete, TNV also enlisted other wetlands that needed conservation. At TNV, we firmly believe that almost all water bodies-from small ponds to large lakes, step wells to rivers and rivulets-have to be conserved by people and the governments, through regulations and through people's support. TNV has been playing its small role, being a tiny CSO driven by passionate and selfless individuals, of protecting our one and only Earth. Over the years TNV has come to be known as "An informal pressure group of environmentally restless people."



Mumbai. Kulpati Dr Jain was the Chief Guest.








